

**THE WIMN / PRS GUITARS GRL PWR GIVEAWAY**  
**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.** Void where prohibited by law. Subject to all federal, state and local laws, regulations, and ordinances. Promotion begins on *Nov 1, 2017* at 12:00 a.m. Eastern Time ("ET") on *Nov 1, 2017* and ends on *Dec 31, 2017* at 11:59 p.m. ET on (the "Promotion Period").

**1. You must provide all required information to be eligible to enter and win. All potential winners are subject to verification before any prize will be awarded. Normal Internet access, phone, and usage charges imposed by your online or phone service may apply. **Limit:** one entry per person during the Promotion Period.
